

Membership Agreement

12 Month Membership Contract-Monthly Payments

Monthly payments are automatically debited from the member's credit card that is on file. The payment is debited on the same day of each month as the first payment (sign-up date). The monthly charges will continue automatically each month for 12 months, or until termination of the membership.

Membership Plans

- 60 minute monthly membership at \$70 per month for 12 months
- 90 minute monthly membership at \$105 per month for 12 months
- 120 minute monthly membership at \$140 per month for 12 months

Membership benefits

The benefit to signing up for a membership program is 1 prepaid massage session per month. Any additional massages for the month will be charged at the discounted membership rate. You may share your prepaid service with a person of your choice with a \$5 transfer fee. Unused prepaids are rolled over month to month.

About your Membership

1. You have the entire length of your membership to use your membership services, as long as your account is not frozen/suspended and is in good standing.
2. Memberships are non-transferable.
3. Memberships will automatically renew. At the end of the initial term, if you choose not to renew your membership, you must decline renewal in writing and submit it to a manager. An email will be sent to the email address we have on file letting you know your membership is coming up for renewal 30 days prior to the end period.
4. Prepaid services may be shared with a person of your choice. You will have to call Salubrious Massage LLC to schedule the appointment and authorize the transfer and agree to transfer fee.
5. Memberships include discounted rates on all massages. Discounted rate does not apply to gift certificate purchases.
6. Salubrious Massage LLC reserves the right to change rules and regulations, and pricing at any time upon reasonable notice.
7. You agree to follow clinic rules. We have the right to discontinue the membership for any unacceptable behavior, and the determination of any such inappropriate behavior shall be in the sole discretion of Salubrious Massage LLC.

Membership Terms and Conditions:

Please initial on each line to confirm that you understand the terms and conditions.

____1. Must be 18 years or older to purchase a membership.

____2. The membership is non-transferable between you and someone else.

___3. When the initial membership term is complete or cancelled, the remaining prepaids will need to be used by the primary membership holder within 30 days from the end date. Prepaids can be transferred to another person with a \$5 transfer fee per transfer.

___4. You agree to provide Salubrious Massage LLC updated information of proof of residency, phone number, email address, and payment information. You agree to notify Salubrious Massage as to any changes to this information.

___5. Salubrious Massage LLC reserves the right to revoke a membership due to any unacceptable behavior, and the determination of any such inappropriate behavior shall be in the sole discretion of Salubrious Massage. You will be responsible for the cancellation fee upon revocation of the membership.

No-show and Same-day Appointment Cancellation:

___6. We respectfully ask that you provide us with 24-hour notice of any schedule changes or cancellation requests. Please understand that when you cancel or miss your appointment without providing a 24-hour notice we are often unable to fill that appointment time. This is an inconvenience to your service provider and causes our clients to miss a chance to receive services they need. For this reason, you will be charged 100% of service fee per missed session unless we are able to fill that full appointment time with another client.

Late Arrival Policy:

___7. We ask that you arrive 5-10 minutes prior to your appointment time to allow time to answer any intake questions your service provider may have. We understand that issues can arise that may cause you to be late for your appointment. However, we ask that you call or text to inform us if the occurs so we can do our absolute best to accommodate you. Appointment times are reserved for each client and cannot exceed that reserved time without making the next client late. For this reason, arriving after your appointment time may result in loss of time. Full service fees will be charged even when the sessions are shortened due to late arrival. In return we will do our best to be on time and if we are unable to do so we will add time to your session or adjust service charge accordingly.

Inappropriate Behavior Policy:

___8. There is absolutely no sexual component of any of our services whatsoever. Any insinuation, gesture, or request will result in immediate termination of your session and a refusal of any and all services in the future. You will be charged the full service fee regardless of the length of your session. Your membership will be revoked, and you will be responsible for the cancellation fee upon the revocation.

Freezing a Membership:

___9. Salubrious Massage LLC knows that hard times come up. You may freeze the membership for up to 90 days per calendar year. When a membership is frozen, it is frozen for at least 30 days. No benefits are available while membership is frozen. Memberships will automatically resume at the end of the freeze date. A membership must be unfrozen for at least 30 days before it can be frozen again. Your membership expiration date will be extended by the amount of time that your membership was frozen. Rules and terms continue to apply through the extended membership term.

Cancellation of Memberships During Initial Term and Fee:

____10. You may cancel your membership during the initial term with a 10 day written notice and cancellation fee. The cancellation fee is 50% of the remaining balance of the term. All requests need to be submitted to management.

____11. Any prepaids will have to be used within 30 days from the cancellation date or they will be forfeited.
